

#### Agribusiness

## Data Protection & Cybersecurity



With a certified and specialized team, we design privacy governance programs that support data flow management and establish measures for LGPD compliance. We draft and review contracts, especially Data Processing Agreements (DPAs), to set rules and security controls between controllers and processors. We also represent clients in administrative defenses before the Brazilian National Data Protection Authority (Autoridade Nacional de Proteção de Dados - ANPD) and other regulatory bodies, as well as in judicial defenses in individual and class actions.

### Media, Sports & Entertainment

RMM advises in judicial and administrative proceedings involving entertainment, media, and sports matters, both in indemnification claims and right-of-reply actions. We also provide consulting in entertainment law, such as contract drafting, assessment of incentive laws, and pre-publication review, among others.

## Public & Regulatory Law

We act in judicial and administrative defense involving Administrative, Constitutional, and Environmental Law, as well as actions for constitutional review. We handle public civil actions and administrative misconduct cases, and provide judicial and administrative defense of public servants and third parties in disputes with public administration. Our team represents clients before audit courts and administrative tribunals, in social security reimbursement claims, expropriations, property restrictions, and before the National Council of Justice (CNJ), National Council of the Public Prosecutor's Office (CNMP), and higher courts. We have expertise in administrative sanctioning law, mediation procedures within public administration, public procurement and contracting, concessions, Public-Private Partnerships (PPPs), and infrastructure.



### Restructuring & Insolvency

We have expertise in representing interests in judicial reorganization proceedings, advising both secured and unsecured creditors, as well as debtors seeking to use this tool. RMM represents creditors and debtors in out-of-court recovery negotiations, aiming to reach consensus and establish an out-of-court recovery plan. Out-of-court restructuring is an excellent path to achieving quick and effective business recovery. Our team represents creditors and debtors in bankruptcy proceedings, seeking credit recovery and the best alternatives and strategies to achieve it.



#### Corporate/ M&A

RMM represents clients in purchase and sale negotiations, asset swaps, equity combination agreements, investment contracts, joint ventures, as well as mergers and acquisitions. We also advise on corporate restructuring for large economic groups and support companies in defining and improving corporate governance rules. We handle a wide range of corporate disputes and defend the rights of shareholders and corporations in partial dissolution actions, liquidation, equity appraisal, partner exclusion, and accounting claims, among others. Our team also works in labor matters and litigation management.
